I. General Information

- a. Name. The name of this committee is Jacksonville State University Institutional Review Board (IRB).
- b. Purpose and Scope. The Institutional Review Board (IRB) is a committee that reviews all JSU research involving human participants and is responsible to the President. The purpose of the IRB is to assure that research is conducted in an ethical manner, specifically in accordance with Department of Health and Human Services regulations (45 CFR 46 Protection of Human Subjects). This includes ensuring that risks to participants are minimized, the selection of participants, is equitable and participants are informed fully of what their participation will entail.

The policy on the use of human subjects in research applies to any activity deemed to be research at Jacksonville State University. The applicability of this policy is to all entities of the university: faculty, administration, staff, students and contracted consultants. This policy applies to any research activity using human subjects that is directly or indirectly supported by the university.

II. **Activities and Significant Accomplishments**

a. Applications. The IRB reviewed 50 research proposals during the academic year 2008-2009 (as of date of report submission). Of these, 45 were exempt, 3 were expedited and 2 were fully reviewed. Minutes of fully reviewed applications are included in "III.a." The names of all applicants and projects are attached in "III.b." All applications were approved.

b. Federal Wide Assurance (FWA). In November of 2003, with the generous support of the President's Office and others, JSU applied for and was awarded the FWA. The Office of the AVPAA continues to sustain the university's FWA through careful record keeping and reporting. This assurance was renewed effective February 3, 2009, and remains in effect until February 3, 2012.

Call to Order and Charge:

Dr. Morris called the meeting to order at 9:00 a.m. and welcomed the committee members. She then introduced Dr. William Meehan, President, who delivered the committee's charge. Dr. Meehan emphasized the importance of protecting human subjects in research and the committee's role in providing oversight, approval and assurance of human subjects' protection.

Old Business:

1. Dr. Delap brought the committee up to date on **past IRB committee work** and provided the committee with the annual report from the previous academic year.

2. **Minutes of the 2008 meetings** provided in the annual report (#1 above) were approved as amended (one incorrect date was changed).

New Business

- 1. Dr. Morris outlined the primary and other **responsibilities of the IRB**, with a handout providing nine key responsibilities of the board. She stressed the importance of providing written feedback to applicants, further providing a set of criteria involved in the approval process (also with a handout). Dr. Hymer suggested a manageable checklist for informed-consent compliance be created and made available to applicants. Dr. Morris committed to working to produce such a checklist and make it available to principal investigators.
- 2. Dr. Thomas asked if **informed consent** applied to anonymous questionnaires and whether notification of IRB approval could be made available to research subjects. All were in agreement that such notification should be made available to the extent possible. Dr. Thomas also recommended creation of a campus-wide database for **email suppression lists**. It was agreed that such a list should be a goal, with the understanding that it can be piloted in individual colleges. Also the question of how follow-ups are conducted was answered by Dr. Delap, who noted that past IRB membership had called for and received these reports from applicants.
- 3. **IRB Application** from Dr. Paige McKercher and Ms. Makenzie Williams, Graduate student, entitled "Evaluation of Preschool Teaching Strategies" was discussed. Dr. Curry asked about the number of children involved in the study, and whether or not the small number posed an increased risk to the research subjects. Dr. Restauri answered that the PIs were familiar to the research subjects and posed no increased risk. It was also noted that the age of the participants, from 1.5 to 5.5 years old, did not particularly pose a greater risk. The membership did not see any problems with the study and approved the application unanimously.
- 4. Appropriate **number of meetings** for the year was discussed. It was agreed that a minimum of three meetings should be held, at least per semester including summer, and other meetings as needed. Electronic meetings are also a possibility as a last resort.

Only one other application was received and deemed "full review." As the application arrived in the summer months and most of the committee members were unavailable for a face-to-face meeting (which is always preferable), the application was handled via electronic means. All members responded.

Meeting of June 25, 2009, to discuss an IRB application from Mr. Jeremy Mallett, Graduate Student, under the direction of Dr. Todd L. McKerchar, Assistant Professor of Psychology, entitled "Choice Behavior in Children." The application was deemed "full review" due to direct interaction with special populations (children under 14 and mentally disabled). Committee members' questions and Mr. Mallett's responses (all of which were deemed satisfactory) are as follows:

1. What are the specific ages of the children?

We anticipate that the children in our study will range between the ages of 2 1/2 and 6 years, as this is the age range The Little Tree Preschool serves (i.e., where the research will be conducted). 2. How many of the children are "mentally disabled," if any?

Currently, The Little Tree Preschool has 8 children enrolled in their program (6 children with a developmental disability and 2 typically developing children). However, this preschool intends to enroll up to 12-15 preschool-age children and they hope that the distribution of typically developing to atypically developing children is 50/50. In our study, we intend to enroll both typically and atypically developing children.

3. What safeguards will be in place to ensure food allergies and choking hazards are avoided in rewards provided/ offered to children?

First, we will talk to the supervisor, staff, and parents of the children regarding food allergies prior to presenting them with any food rewards in the study. Second, if a food allergy is identified by the staff or parents for a particular child (e.g., peanuts), that item will be excluded from the study as a possible food reward. Third, if the child has a known food allergy, we will ensure that this item is not an ingredient in another food reward (e.g., peanuts in chocolate). Finally, prior to presenting food rewards to the children, the researchers will cut the larger items into appropriate bite-size amounts. We should also point out that at least one staff member certified in CPR will be at the preschool at all times (per DHR regulation). Thus, we will be able to administer CPR in the unlikely scenario that a child does choke on the food item.

4. Will at least two adults be present with the children during administration of the trials?

There will always be at least two adults present with each child during the conduct of this research. Currently, both Dr. McKerchar and myself plan on being with the children at all times. It is possible that at a later date, we may recruit one or more undergraduate psychology students to help with data collection. However, should we anticipate a change or addition in personnel, we will let the IRB know in advance.

The application was approved.

One other application, from Dr. Ron Mellen, was originally thought to be "full review" but later deemed to be a renewal and handled by the Secretary and Chair as "expedited."
