

#### Testing: National Counseling Exam/Prep Course

The **National Counselors Examination (NCE)** administered by the National Board of Certified Counselors (NBCC) is an important and required tests for many goals and objectives in the Counseling field. Here are some requirements and benefits specific to a JSU counseling student:



*Masters of School Counseling (Non-traditional/CACREP track)*: NCE required for certification, not graduation, as a School Counselor in the state of Alabama.

Masters of School Counseling (Traditional track) & <u>Master's in Clinical</u> Mental Health Counseling: Not required for JSU graduation, The NCE is required for licensure as ALC and LPC in the state of Alabama and other states.

JSU Counseling program has an Institutional Participation Agreement with NBCC, which provides an opportunity for students to take the NCE before graduation. Interested students that have reached their Practicum or Internship are eligible to apply. Names are submitted and then NBCC emails options for testing. Students then have a six-month window to schedule tests once they receive a response from NBCC.

#### PRAXIS (School Counseling Majors)

As of Fall 2025, the JSU School Counseling program adopted the School Counseling Praxis Test as the Final Comprehensive Tests for the program. Passing this test is now a requirement for graduation. This decision aligns with the other certification programs and degrees offered in the JSU School of Education. It also meets the requirements for certification as an Alabama school counselor upon the student's graduation.



#### Midpoint Exam - Dr. Torsten Dryden

The Assessment Committee established a benchmark of 80% pass rate for all students taking the Midpoint Exam in any term. That is, in any term in which less than 80% of all students taking the Midpoint Exam pass the exam, faculty will investigate the specific areas of the exam (i.e., the eight CACREP Core Areas) in which the deficiencies occurred, evaluate the course mapping, course content, and make essential program modifications. Preliminary examination of Midpoint Exam Data from MONTH 2022- MONTH 2024 reveals

the following results:

# Midpoint Exam continued...

The table in the previous slide represented pass/fail rates for the three iterations of the Midpoint Exam (Academic Year 2023-2024), shows that each of the three iterations surpassed the benchmark of 80% pass rate on the first attempt. Should the benchmark on any iteration of the Midpoint Exam not meet the benchmark of 80% pass rate, the faculty Midpoint Administrator will review the exam of the one who failed and identify which of the eight core areas was problematic. Faculty will evaluate course syllabi and content, as well as the Midpoint Study Guide, for opportunities to strengthen that area. If data from the Midpoint Exam continues to be non-discriminating and thus disallowing significant assessment of aspects of the program, it will be revamped with more discriminating items or discontinued as an assessment piece. Consideration in this case would be given to implementing the Counselor Preparation Comprehensive Examination (CPCE) or the CECE as a Midpoint Exam.



### **Comprehensive Exam**

 There was a 100% pass rate for all students in the clinical mental health counseling and school counseling programs during the fall 2023 semester, the spring 2024 semester, and the summer 2024 semester.
