Course and Range Location: Meeting in Piedmont, Alabama – Site of the Northeast Alabama Law Enforcement Academy range. Call for directions.

Program Description: This course basic Police Sniper Course (Level 1) is designed to familiarize and complete multiple precision shooting_qualifications. Instruction consists of skills and tactics including hostage situation management; instinctive firearms training, wind and weather, angles, shooting through glass, night fire and independent/select shooting. The shooting tables are challenging and should not be taken lightly. Standards are not yielded. Expect three challenging days. Night fire occurs in the program.

Ammunition: Bring match grade ammunition. Non-match grade ammo will not hold the groups we are required in the learned outcomes.

Weapons: Students should already know the weapon, optics and have a basic understanding of their gear. Personally/custom built rifles should be checked by professional armorers to ensure stock to barrel fits are in the correct tolerances. Scopes should be affixed correctly without canting. Zero your rifle prior to attending.

Qualifications: ALL qualifications are difficult. Students will have challenging qualifications courses each day. Students MUST qualify on handgun, iron sights, and scoped weapons. During each qualification stage, if a student fails the stage of fire, the student will be given one (1) chance to reshoot each stage. If a student fails both the primary qualification and re-shoot opportunity, the student receives a certificate of attendance instead of completion. Students will also engage targets during a combat course requiring moderate levels of physical fitness. Students will qualify at the 100-yard mark and closer. Students will familiarize with targets out greater distances.

Instructors: Instructors assigned to coordinate and work with these programs have a significant background in law enforcement/military and special weapons training. The instructional staff includes personnel from federal law enforcement, military, former state department and municipal law enforcement agencies. All instructors assigned to teach in these programs attend special instructor training programs in the disciplines assigned.

Standards: Complete all training objectives and designated courses of fire which include combat courses under time as well as the use of the handgun.

Learning outcome of the training (what am I getting): The student will be able to engage targets with 100 percent accuracy out to 100 yards with a scoped rifle capable of delivering lethal fire during law enforcement operations.

Each student needs to bring:

- \circ $\,$ Wrap around eye protection and foam hearing protection $\,$
- Duty Handgun with at least two serviceable magazines
- Note pad, pen and water
- Cleaning gear for all weapons
- o Shooting mat or blanket
- o Wet weather gear, bug spray, sun block, etc
- Folding chair for comfort on the range
- Spotting Scope if possible
- Something to cover your head (large scarf, towel or cloth) to cover your head

Weapons and Ammunition

- ✓ Rifle should be capable of holding 1-inch groups at 100 yards.
- ✓ Ammunition should be Match Grade.
- ✓ Pistol with holster and at least three magazines 100 Rounds *(yes, that says pistol)
- ✓ Iron Sighted Rifle with at least two magazines and 150 Match Grade Rounds
 - Yes, that says iron sights.
 - We will be shooting with iron sights only there are reasons.
- ✓ Scoped Rifle (Bolt or Semi Auto with magnification or scope) and 250 Match Grade Rounds

Payment: Checks, Money Orders and Credits cards (must call me for credit cards) must be made out to ARM Group LLC. Payment MUST presented on the first day of class unless other arrangements have been made. If the agency must have an invoice, we can prepare an invoice for your agency.

Firearms: The student will learn the weapon safety rules and abide by the rules at all times. We cannot afford an unsafe student in any class. Safety violations are dealt with swiftly. The student should be able to load, unload, and reload their firearm in a SAFE and CONTROLLED manner. Unless attending a basic weapon program, the student should be familiar with their weapon systems and equipment and

possess the basic knowledge to be able to disassemble their firearm for cleaning, maintenance, and problem solving.

Physical Attributes: The student must possess the physical strength and stamina to repetitively manipulate and fire their weapon during prolonged drilling, in all weather conditions. The student must be able to get up and down from a standing, kneeling, and prone position, as well as move forward, backward, and laterally. We do not conduct physical fitness during training programs. That is not our job - that is your job to be fit.

Gear: The student, regardless of duty position, needs to arrive with the proper gear and equipment in relation to the weapon systems that will be taught and used. For example, if a road officer arrives for tactical training without any type of tac vest or equipment is unacceptable and undermines the training being conducted – it delineates the training value. This also includes gear for inclement weather, a method of hydration, etc...

Training: The instructors take the time to guide, mentor and explain the material effectively. They also take the time to analyze and inform the shortcomings of students then make corrections to improve the overall performance of the student. Each student is evaluated and performance increased.
