**Program Description:** This approved Basic Tactical Operators Course (BTOC) will certify each student. Anyone certified LEO may attend this training, assignment to a team is not necessary. The training days are long. The learning objectives will fatigue the student. The student must be able to walk, run short distances, kneel, squat, bend, assume prone positions and recover to any position unassisted.

**Credentialing:** This course is for active, certified and credentialed law enforcement officers (LEOs) with detention and arrest authority.

**Equipment List:** Each student needs to bring:

- Wrap around eye protection, Hearing protection (bring lots of foam hearing protection)
- Body armor/tactical vest/gloves
- Flashlight: weapon mounted and/or handheld with spare batteries
- Duty pistol, 3 magazines and holster – Pistol Ammunition: 300 Rounds
- A zero'ed rifle, 3 magazines, Rifle Ammunition: 150 Rounds
- Groin protection (Small towel or athletic cup), Long sleeve T-shirts, no red clothing – Instructors wear red
- Throat protection (towel) and groin protection (towel)
- Non-lethal training weapon (Glock 17T or similar) – we can provide if necessary
- Season weather clothing (Rain gear, changes of clothes, etc...)

**NOTE:** This course uses non-lethal training ammunition during force-on-force training. Students must bring items that cover exposed skin during training. Bring something to cover your neck, arms, hands and pad the groin area.

**Training Ammunition:** Each student needs to bring:

- 150 Rounds of Non-lethal training ammunition (NLTA), which fits Glock 17T handgun
- 20 Rounds of Force on Force 5.56 rounds
- If you cannot provide rounds, please contact Dave personally (256.525.9808)
- We do not accept digital purchase orders.

**Lodging:** Tuition does **not** include lodging. Students must make their own arrangements.

**Minimum # Students:** 10

**Maximum of Students:** 24

**Physical Attributes:** The student must possess the physical strength and stamina to repetitively manipulate and fire their weapon during prolonged drilling, in all weather conditions. The student must be able to get up and down from a standing, kneeling, and prone position, as well as move forward, backward, and laterally.

**Gear:** The student, regardless of duty position, needs to arrive with the proper gear and equipment in relation to the weapon systems that will be taught and used. For example, if a road officer arrives for tactical training without any type of tac vest or equipment is unacceptable and undermines the training being conducted – it delineates the training value. This also includes gear for inclement weather, a method of hydration, etc...

**Training:** The instructors take the time to guide, mentor and explain the material effectively. They also take the time to analyze and inform the shortcomings of students then make corrections to improve the overall performance of the student. Each student is evaluated and performance increased.
