Update From the Chapter President



Greetings fellow Gamecock Battalion Alumni. On behalf of the ROTC alumni board of directors, I hope that you and your family enjoy a safe and prosperous new year. Quite a bit has happened since our last newsletter. We have a new PMS, celebrated our 19th annual alumni banquet, recognized COL Barry F. Graham as our Military Alumnus of the

Year, presented 21 scholarships at the fall awards ceremony, participated in the fall commissioning ceremony, and recognized our first four Chapter Champions.

LTC David Wood is our new PMS, coming to us from a recent assignment as the Afghan National Security Forces Logistics Development Branch Chief for Regional Command – East. Although LTC Wood has only been with the program a few months, he hit the ground running, making a rapid assessment of the issues and causes of the program not commissioning 15 lieutenants a year (Cadet Command's measure of a viable R.O.T.C. program), formulating a plan, and working that plan in order to produce 15 or more lieutenants a year. We are excited about LTC Wood's plan and the energy that he brings to the chapter.

We had the pleasure of recognizing COL Barry F. Graham ('88) as our 2014 Military Alumnus of the Year. Barry currently serves as the Assistant Chief of Staff, G2, for Third Army/USARCENT which conducts split-based operations between Shaw AFB, SC and Camp Arifjan, Kuwait. We were very fortunate to have COL Graham come home from Kuwait to join us.

On December 4, the alumni chapter participated in the fall awards ceremony, presenting twenty-one, \$1,000 scholarships. Our scholarship sponsors currently contribute \$500 each annually, which is matched by the university.

On December 19, we participated in the commissioning ceremony for our three newest lieutenants and newest members of our alumni chapter.

During our alumni banquet, I had the pleasure of recognizing our first Chapter Champions. This award is intended for those whose ongoing support and commitment to the chapter is unmatched. COL (Ret.) Therman Greene ('59), LTC (Ret.) Joe Serviss ('69), LTC (Ret.) Bruce Pickette ('68), and Dr. William A. Meehan are the first of our Champions.

Chapter Status

The Department of the Army considers R.O.T.C. programs that commission less than 15 lieutenants a year to be non-viable. Our program has produced an average of 13 lieutenants for the past five years, placing us in the non-viable program category. Some of you may have heard that our program was included on a list of programs being recommended for closure. I am happy to report that the list was not processed and the program will remain in operation, but still faces a period of uncertainty as to what the program may look like in the next few years. MG Peggy Combs, the Commander, Cadet Command, is adamant about not closing any programs at this time, but will take her cues from the Pentagon based on funding availability and the need for R.O.T.C. Commissioned Cadets. Although the program is still operational, we may face issues over the next couple of years as we do not have enough cadets to meet the 15 lieutenant requirement in our MS III and MS IV classes. Dr. Meehan and LTC Wood had an opportunity to address visitors from Cadet Command on October 30 and made a strong case for keeping our program off of any closure lists, especially given that we will begin to meet the commissioning requirement beginning with our current crop of MS IIs.

Chapter Officers

We are looking for members who would be interested in serving as either the 1st Vice President (succeeding me at the end of the year) or the 2nd Vice President. We have a dedicated core group of long-time chapter officers who have carried the alumni chapter since its inception and are looking to bring in new officers to learn and carry on the tradition and efforts of the chapter.

LTC David Wood was initially commissioned in May 1997, as an active duty Quartermaster Officer from the University of Colorado – Colorado Springs with a Baccalaureate in History. Update from the PMS, LTC David Wood

I would like to thank the Alumni for your kind reception of my family and me. We feel very much part of this rich tradition here at JSU and the ROTC program. I also want to thank you for the continued outstanding support you give this program and its Cadets. I firmly believe that we have all the key components to turn the program back onto the trail of consistent success.

Here are some key program updates:

We continue to move forward in rebuilding the program despite the uncertainty that surrounds our program and the 38 other ROTC programs that are viably challenged. We should receive word in FEB 15 as to the future of the Annual Program Review system and an initial decision on probations and guidance on program closures. I firmly believe we will not be closed but we will be required to make changes in our manning structure. We made our commission mission last year and we will fall one short this year. I remain concerned about the impact of our Mission Set 16 cohort on this process. I am proud of the hard work that we have placed into re-building Mission Sets 17-19. JSU's support for our program remains outstanding. We just received word this month of the University granting 25 ROTC tuition scholarships that will greatly enhance our ability to recruit quality freshmen (to include those recently returned from Basic and AIT) by awarding a scholarship equivalent to six credit hours.

Our program continues to move in a positive direction during this time of change. Our Cadets recognize the Army's need for quality officers. This past year's Accessions demonstrate just how competitive Active Duty commissions are as seen in this cohort's average 3.4 GPA and over 270 APFT score. We continue to stress that all three Components must have quality leaders as we continue to meet the Nation's requirements.

Positive signs of our recruiting campaigns can be seen in the growth of our Spring MS II class with the addition of five Cadets and in our Spring MS I class with the addition of 11.

This next summer's Cadet Summer Training will reflect the commitment to training and developing adaptive, problem solving leaders. The MS IIIs will attend the Cadet Leadership Course this summer. The greatest change from years past is the removal of the evaluation system which is now replaced by a counseling program. Additionally, we will send 5-6 MS Is and 3-4 lateral entry students to Cadet Initial Entry Training.


