REPORTING

You can make a report anytime and anywhere, even if you're not the impacted individual. You can report any information to the Title IX Coordinator in any of the following ways:

- By mail
- By telephone (256.782.5769)
- By email (titleix@jsu.edu)
- By completing the "Report a Concern" form on the Title IX web page
- By any other means that results in the Title IX Coordinator receiving the person's verbal or written report.

- Notify and cooperate with the university

SUPPORTIVE MEASURES

Supportive measures serve to restore or preserve access to the living, learning, and working environment; to protect students and employees; or deter sexual harassment. They may include, but are not limited to:

- Referral to University or community counseling, medical, and/or advocacy services
- Free STD Testing (no insurance needed)
- Referral for Sexual Assault Forensic Exam (no insurance needed)
- Altering campus housing assignment(s)
- Altering work arrangements for employees or student-employees
- Safety planning
- Providing campus safety escorts
- Academic support, extensions of deadlines, or other course/program-related Adjustments
- Class schedule modifications, withdrawals, or leaves of absence
- Protective Order issued under state or federal law
- Any other actions deemed appropriate by the University Title IX Coordinator or designee

RETALIATION IS PROHIBITED

No one is allowed to retaliate, intimidate, threaten, coerce, or otherwise discriminate against any individual for exercising their rights or responsibilities under JSU's Sex-Based Harassment and Misconduct Policy.

Retaliation can be any act or attempt to retaliate or seek retribution against any individual or group of individuals involved in the report, investigation, and/or resolution of any allegation of sex-based misconduct, harassment, or discrimination.

PARTIES' BILL OF RIGHTS

All members of the Jacksonville State University community have the right to:

- Make a report to UPD or local police
- Make a report to the Title IX Coordinator and/or any Deputy Title IX Coordinator
- Have disclosures treated seriously
- Decide to participate in the Title IX process and/or criminal justice process free from pressure by the university
- Participate in a process that is fair, impartial, and that provides an opportunity to be heard
- Receive courteous, fair, and respectful health care and counseling services
- Have access to an appeal of any determination
- Be accompanied by an advisor and/or support person of choice throughout the conduct process
- Right to be free of Retaliation
